Panelist Background Information

Alex Basilevsky – Partner, Obermayer Rebmann Maxwell & Hippel LLP

Alex is a partner in Obermayer's Litigation Department. He concentrates his practice in the areas of complex litigation and environmental law. He often represents clients in litigation driven by complex expert testimony of a technical and/or scientific nature, including both environmental and non-environmental litigation. Alex represents clients dealing with litigation arising from environmental contamination and resultant toxic torts. This includes representing clients alleged to have caused or contributed to environmental contamination, as well as representing clients who have been harmed by environmental contamination. He has represented a number of energy companies in New Jersey and Pennsylvania in litigation regarding fuel spills. He also has first chair trial experience, under both State and Federal law, with a focus on soil and water contamination. Alex has also guided clients through litigation against large financial services companies and investment banks. He served as special litigation counsel to the Chapter 7 Bankruptcy Trustee of American Business Financial Services, Inc. (ABFS) in litigation against ABFS's former officers, directors, lenders, attorneys and accountants, amongst others, with respect to allegations of breaches of fiduciary duty, fraud, aiding and abetting, and negligence associated with the 2005 collapse of ABFS. The litigation resulted in the recovery of more than \$140 million for ABFS's creditors.

His areas of specialty include examinations under oath, automobile theft, arson, suspect medical and chiropractic treatment and the avoidance of "bad faith" in the investigation of first party claims. In addition to defending general liability claims, Jon has firstchaired countless jury trials, arbitrations and mediations involving suspect losses of all types. His experience extends to unlawfully operated medical facilities clinics, illegal and upcoded medical billings, suspect chiropractic and medical treatment, staged automobile accidents and staged slip-and-fall incidents. Jon obtained his undergraduate degree from U.C.L.A. in 1975 and his law degree from Southwestern University School of Law in 1980.

As a prosecutor, he was responsible for state-wide enforcement of all Massachusetts environmental laws. Nick also worked as a Chemical Engineer for Johnson Matthey, Inc. before attending law school, supervising chemical processes at the world's largest catalytic converter plant. Nick began his career as a trial attorney as a prosecutor and he has continued with his trial practice to the present. Over the course of his legal career, Nick has tried over forty cases to verdict, including both environmental and product.

Melissa Richardson – Member, Walters Meadows Richardson, PLLC

Mrs. Richardson is a trial attorney. In her practice, she handles all aspects of litigation with a strong focus on insurance defense, including trucking litigation, wrongful death, and bad faith claims. Mrs. Richardson has tried over a dozen cases and has the distinction of being identified as the "Most Prolific Trial Attorney" in 2011, when she tried five cases to verdict. Mrs. Richardson led the list of the top twenty-five attorneys identified and was the only female to receive that distinction. Ms. Richardson routinely tries several cases per year. The bulk of her work is in Kentucky, where she has lived the majority of her life. She also handles matters in other states upon obtaining limited admission from other courts. Most recently she obtained a favorable verdict for her clients in a sizeable claim that stemmed from an accident between two semis just north of New Orleans, LA.
